#### 3.1 Request for Extending 50kph Speed Limit West on Lismore Road, Bangalow

**14-513 Resolved** that Council note that, following recent RMS advice, the location of the transition 50/80kph on Lismore Road near Rifle Range Road in Bangalow will remain unchanged. (Woods/Richardson)

#### 5.1 Park and Ride, Bus Lane and Special Event Parking Area (SEPA), Byron Bay

#### 14-514 Resolved:

- 1. That the Local Traffic Committee supports Council's temporary traffic management initiatives for Byron Bay for the seven (7) days from Monday, 29 December 2014 to Sunday, 4 January 2015 inclusive, and approves for the same period the:
  - a) conversion of the parking lane on the north side of Shirley Street , Byron Bay between Kendall Street and Wordsworth Street into a bus lane
  - b) declaration of a 2P Special Event Parking Area (SEPA) which applies to all roadrelated areas east of the Belongil Bridge on Ewingsdale Road and north of Seaview Street, Byron Bay as per the Schedule of Streets at Table 5.1.1
  - c) extension of existing signed time limits through to 12midnight
- 2. That the above approval remain subject to Council endorsement prior to implementation and is subject to the following requirements:
  - a) advertising as required by the Roads Act plus the publication of a SEPA map, effect streets and explanatory notes in a local newspaper and on Council's website;
  - b) the letterbox drop of Shirley Street properties prior to the commencement of the bus lane;
  - c) that the signage and its installation are done as per any relevant NSW requirement, be it legislation, regulation or guidelines such as those published, for example, by Transport for NSW (TfNSW) or RMS; and
  - d) that Council write and advise the Tweed-Byron Police command, local Byron Bay police station and the RMS Regional Office of these temporary changes.

#### 5.2 New Year's Eve, Byron Bay Road Closures and Traffic Management

#### 14-515 Resolved:

1. That the Local Traffic Committee supports Council's temporary traffic management initiatives for Byron Bay New Year's Eve and approves:

a) the road closure of Jonson Street, Byron Bay between Lawson Street through to the car park entry at Railway Park (north of Marvell Street) from 1pm on 31 December 2014 and its removal by no later than 7am 1 January 2015;

- b) the removal of on-street parking on Bay Street, between Jonson Street and Middleton Street, effective from 6am on 31 December 2014 and removed by no later than 7am 1 January 2015, noting earlier removal is acceptable and be considered given the 'First Sun' activities planned for the foreshore.
- 2. That the above approval remain subject to Council endorsement prior to implementation and is subject to the following requirements:
  - a) traffic management plan (TMP) and implementation is done by those with the appropriate NSW (RMS) accreditation;
  - b) advertising undertaken as required by the Roads Act plus the publication of a map and explanatory notes in a local newspaper and on Council's website;
  - c) the letterbox drop of properties adjacent and prior to the Jonson Street closure and Bay Street parking changes;
  - that all parties involved in Council's NYE events hold, or least covered by, appropriate and relevant levels of insurance and public liability cover as required by Council; and
  - e) that Council write and advise the Tweed-Byron Police command and RMS Regional Office of these temporary changes once finalised.
- 3. That Council also consider the benefit of removing on-street parking in Middleton Street, between Bay Street and Lawson Street on New Year's Eve which can be done as part of the aforementioned Traffic Management Plan (TMP). (Woods/Richardson)

#### 5.3 s138 Approval for Driveway Crossover, Ambulance Station, 54 Ewingsdale Road

#### 14-516 Resolved:

- 1. That Council, in noting the concerns raised within this report (at Item 5.3, file #E2014/65197), support the Local Traffic Committee recommendation as follows.
- 2. That RMS concurrence for the Ambulance Station Crossover (driveway) at 54 Ewingsdale Road (Lot 100, DP 1140936) be granted, subject to the land owner providing written agreement within one month of notice being served upon them (or their nominated agent) that they:
  - a) will within three (3) months of the date of that agreement provide a Basic Right (BAR) turn treatment and a rural property access standard for left turn in and out as per AustRoads Guide to Road Design
  - b) agree the median proposed as part of the Byron Central Hospital DA not occur and instead submit a proposal for an automatic gate placed across the driveway that opens on demand and restricts use to Ambulance and other emergency vehicles only
  - c) accept all other vehicle access to the hospital and ambulance sites be via the proposed roundabout west of the subject site

 have arranged for the vegetation to be cleared from the subject site to provide intersection sight distances as required by the relevant Australian Standards and /or AustRoads Guides.

#### 5.4 Ewingsdale Road Safety Review - Update and Immediate Actions

- **14-517 Resolved** that in regard to the Ewingsdale Road safety review resolved upon by Council (Res 14-195), Council note the onsite review has been undertaken and a series of recommendations are being developed, with the priority being addressed as follows:
  - a) endorse the black spot nomination for a roundabout at the intersection with McGettigans Lane;
  - b) more immediately, develop a detailed design for providing cost estimates and securing funding to improve the intersection including:
    - i) extending the hold line
    - ii) providing for cyclists including diversion and fencing of the existing shared path
    - iii) transition from on to off road for cyclists continuing from east to west of the intersection, noting the concept depicted in Figure 5.4.1
  - note Part 2 of 14-195 is being met by Council's 2014/15 funding of the shared path at the frontage of Island Quarry (IQ) opposite the sports complex (BRSCC) and will be put forward to the RMS for a funding contribution;
  - d) develop further and submit for 2015/16 RMS cycleway funding the concept depicted in Figure 5.4.2, which is estimated to cost \$35,000 to provide:
    - i) fencing
    - ii) advanced signage
    - iii) improved and new line marking
    - iv) pavement and
    - v) street lighting required to improve crossover safety
    - vi) consider the transition for cyclists continuing west
  - e) request RMS to extend the Ewingsdale Road 60km/hr speed limit from its existing location at 100m west, to a new location 100m east, of Banksia Drive, Byron Bay.

#### 5.5 Street Parade, Mullumbimby Music Festival, Sunday 23 November 2014

#### 14-518 Resolved:

- 1. That the Mullumbimby Music Festival Street Parade scheduled for Sunday, 23 November 2014 be endorsed, including the temporary road closure of:
  - a) Dalley Street, Mullumbimby between Tincogan Street and Burringbar Street which is effective between 11am and 12noon
  - b) Burringbar Street, Mullumbimby between Station Street and Dalley Street which is effective between 10.45am and 11.15am
  - c) Lane 7, between Dalley Street and east of the Fire Station driveway, and Lane 2, from Lane 7 to Tincogan Street, with both in effect from 4pm Thursday 20 November 2014 through to 8am Monday 24 November 2013
- 2. That the temporary road closure be subject to the following conditions:
  - a) That the organisers be responsible for implementing a Traffic Control Plan, including the use of signed detours, as designed and implemented by those with appropriate accreditation and be advised Council's fee for holding an on-road event will apply
  - b) That each bus stop required by the event shuttle bus be established in accordance with a Traffic Control Plan when and as necessary
  - c) That public liability insurance be in place for the sum of at least \$20 million

- d) That the concurrence of NSW Police and NSW Fire be obtained by the organisers, independent of the Local Traffic Committee endorsement
- e) That the event be advertised in accordance with the Roads Act, charged at cost to the organisers
- f) That the event be notified on Council's website
- g) That if Council staff and materials are required for the event, costs be recorded and invoiced to the organisers as appropriate
- 3. That Council advise the applicant that a minimum of three months notice is necessary in future years. (Woods/Richardson)

#### 5.6 Request for School Crossing, Ocean Shores and Byron Bay Public Schools

- **14-519 Resolved** that Council note Local Traffic Committee support for developing Children's Crossings on Middleton Street, Byron Bay south of Carlyle Street and on Shara Boulevard, Ocean Shores north of Kallaroo Circuit, subject to the following:
  - a) the RMS warrant being met (pedestrian and vehicle counts)
  - b) the respective Principals of Byron Bay Public School and Ocean Shores Public School entering into appropriate agreements with the RMS.
- **14-520 Resolved** that RMS funding be sought for the two children's crossings described, with preference funding enables their implementation prior to the commencement of the 2015 school year. (Woods/Richardson)

#### 5.7 Request for 'No Stopping' south side of Leslie Street, Bangalow

- **14-521 Resolved** that written notification is provided to all tenants and owners adjacent to the subject site of the proposal, which is to sign and enforce No Parking which applies each Sunday and on the north side only of Leslie Street / Rankin Drive, Bangalow from Granuaille Road to Bannister Court. (Woods/Richardson)
- **14-522 Resolved** that this consultation period provides 28 days for any submissions and also includes:
  - a) the Bangalow Sunday markets and Chamber of Commerce;
  - b) a public notice within Council's public notice section of The Echo newspaper;
  - c) an alternative option whereby the markets are responsible for installing temporary No Parking signage each market day; and
  - d) a report back to Council.

#### 5.8 Twilight Markets 2014 Road Closure, Mullumbimbi Street, Brunswick Heads

#### 14-523 Resolved:

- 1. That the temporary road closure of Mullumbimbi Street between Park Street and The Terrace, Brunswick Heads from 12 noon to 12 midnight on Wednesday, 17 December 2014 be approved for the holding of the annual Twilight Markets.
- 2. That the temporary road closure be subject to the following conditions, that:
  - a) the temporary traffic arrangements and road closure be undertaken as per a Traffic Control Plan as designed and implemented by those with appropriate accreditation

and includes the provision of two temporary accessible (disabled) parking bays outside the Brunswick Heads Hotel from 7am to 12noon;

- b) public liability insurance be in place for the sum of at least \$20 million;
- c) the concurrence of NSW Police be obtained by the organisers, independent of the Local Traffic Committee endorsement;
- d) the event be advertised in accordance with the Roads Act, charged at cost to the organisers;
- e) the event be notified on Council's website;
- f) the applicable Council fee for lodgement of a road event application be recouped from Council's donation toward the event; and
- g) if Council staff and materials are required for the event and exceed Council's funding contribution, the organisers be invoiced as appropriate.
- 3.
