Thank you for your email.

As discussed the current licence for Artisan markets at Railway Park requires rent to be paid for 52 markets per year.

A report will now be tabled at the May Council meeting to amend the licence to allow for the markets to be suspended for the months of May, June, July, August & September with an option to start up earlier by written consent of Council. Council publically advertised the proposed variation to the licence mid last year, and received no objections.

Currently all market licences held by the BBCA expressly set the number of markets to be run per year for each year of the licence. The community market and beachside artisan market licences cannot be amended being Trust licences issued by Ministerial consent.

Council has scope to amend the market licence for Railway Park to provide for non-payment of rent upon a cancelled market but would require a Council resolution to do so. Please advise if the BBCA requests such a resolution from Council.

Finally schedule 2 of the market licence for Railway Park requires a report to be submitted to Council by 31 December each year that includes (iv) the market stall numbers per annum reconciled to the audited Market Income.
