- 1. Consents to Council constructing a temporary access road in Reserve 82000 on the area known as the Clarkes Beach Park, as part of the construction of the concrete roundabout at the intersection of Massinger Street, Lighthouse Road and Lawson Street.
- 2. Consents to the temporary access road removing 10 paid parking spaces for approximately 6 months.
- 3. Consents to Council remediating the park turf and reinstating the car park to original parking configuration once the temporary access road is removed following completion of the roundabout in late 2016.
- 4. Issues Council a temporary licence for the temporary access road located on land shown in the attached plan Option 1 (E2016/22531). (Dey/Woods)
