We're writing to advise you that we do have concerns with the proposal as it doesn't assist our individual homes with a street address.

Our access point is from Brunswick St but along our road there are 7 homes within the following;

O'Donnell - Lot / Section / DP = 1/612988
O'Donnell - Lot / Section / DP = 12/612989
O'Donnell - Lot / Section / DP = 5/543430
O'Donnell - Lot / Section / DP = 1/173977
O'Donnell - Lot / Section / DP = 12/612989

Perhaps if we named the road itself we could then have numbers to our individual homes.
