Thanks for your phone call.

I tried calling your number 0266267095 but for some reason the call won't go through so here is an email on some of the products. If you can let me know what products and quantity you might be needing I can send a quote through to you.

I have attached information on the following;

- **Mobi-Mat / AFX Blue Jay:**
- **Mobi-Roll N Stow:** Used for quick rollout and collection of 1.5m wide mat products
- **Mobi-Chair:** The best product we've found for bridging the gap between Mobi-Mat and getting into the water (with assistance)

We provide the Mobi-Mat in lengths of 10 metres to enable greater manoeuvrability and configuration including turns, equipment storage and the variation in tidal heights.

Regarding other beaches providing beach access, have a look at the directory on <https://accessiblebeaches.com/> where you will see a full list of beaches. Another 8 beaches will be added to this list come christmas but there doesn't seem to be any around your area. The contact details for the beaches are listed in the directory so you're welcome to call them and ask about their access.
