Thanks for the opportunity to comment on the Byron Shire Council All Abilities Access Report.

As indicated in the report, the up grading of existing beach access tracks at Clarkes Beach and Main Beach to enable all abilities access to the beaches is consistent with the objects of the *Marine Estate Management Act 2014* and the purposes of marine parks and is supported.
