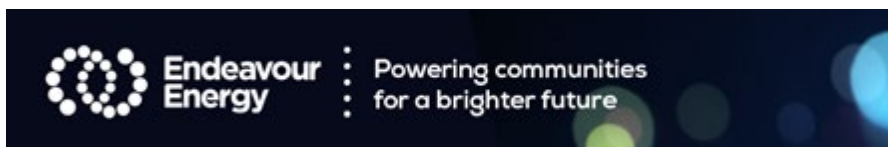

I really appreciate your patience and send my apologies for the delay.

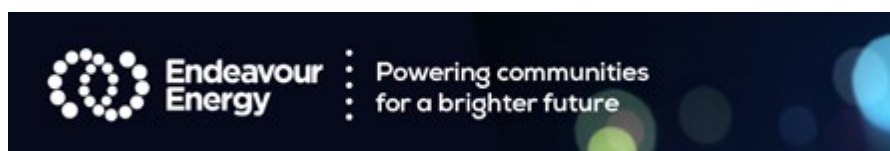

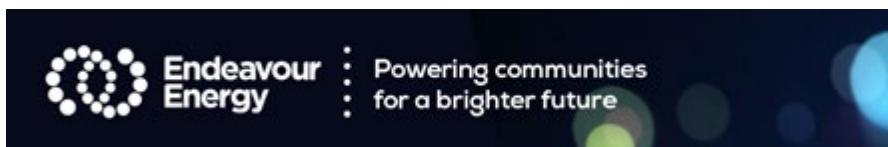
