## Comments on proposed road closures.

Dear Sir/Madam

**I/WE wish to provide my/our opinion in relation to the proposed road closures.**

We believe that there are additional factors to be considered so that a measured and objective decision may be reached.

1. There is a third party who has purchased 4 blocks at the top of Chinaman's Hill Road. One of these blocks has a building entitlement. At present there is no right of way to any of the blocks. However the map attached with this letter, provided by Council with the proposal letter, would indicate that indeed the road proposed for closure is a legitimate right of way to access these blocks.

I appreciate that the land owners of the property through which this road traverses does not wish to have this as a thoroughfare, hence the proposed closure. The third party is currently accessing the block via a private property from Yelgun.

2. It is our understanding that the land owner and the third party would like access to the blocks to be via Chinaman's Hill Road. This has some implications which require consideration.

- The bridge on Chinaman's Hill Road crossing Slacks Creek is old, narrow and in disrepair. Access is cut off in times of flooding, sometimes for many days.
- The width of Chinaman's Hill Road itself is ever diminishing as it erodes into the creek.
- At present Chinaman's Hill Road gives access to 6 properties these being:

252 Middle Pocket Road, Number 26 Chinaman's Hill Road as well as Number 36, Number 49 and then number 50 which is owned by the land owners and also the land owners can access their property via a purchased easement from number 36.

- You could say that the road and bridge are already at capacity. An increase in traffic would exacerbate the decline of the road, increase dust to the house number 26 and would have potential impact on the pleasant amenity of the environment.

3. It is also a concern that should access be granted via Chinaman's Hill Road to the third party's blocks that the third party could further develop the blocks, hence increasing the demand on Chinaman's Hill Road. We have already experienced over development with another neighbour.

In conclusion we do not believe that this is a simple "yes"/"no" response. All aspects require consideration. Maybe there is an alternative solution or a compromise. I trust that an amicable and safe outcome can be achieved.
