The Byron Shire Rebels Rugby Club (the Rugby Club) has participated actively in the processes leading to the draft Plan of Management (PoM). We are grateful to the Byron Shire Council and to the consultants for the opportunities to be involved. The draft PoM overall reflects the key objectives of the Rugby Club. In particular we are pleased to note that it: • Maintains Shultz Oval as the rugby field • Provides for the essential redevelopment of the change rooms • Provides for upgrading of the surfaces of the fields and raising of the levels where feasible to reduce flooding • Allows for additional "club support facilities/storage" in the area near the tennis courts. The one objective of the Rugby Club that is not included in the draft PoM is to find space for a junior rugby field large enough to accommodate at least up to under 11s. The Soccer Club has consulted closely with us in the development of their submission to this process and we support the options that they have identified to re-orient the main rugby field and undertake other necessary works to provide room for a junior rugby field (110m x 60m) alongside a full size field (120m x 70m). We note that it would be important in any such changes for the needs of the Cricket Club to also be addressed. There would clearly need to be further work undertaken to assess the cost and feasibility of such changes but we suggest that the PoM should allow for the possibility of two rugby fields on Shultz Oval as described above. The Soccer Club has also consulted closely with us in relation to other aspects of their submission, in particular as regards the needs for redevelopment of the changerooms. The Rugby Club endorses the Soccer Club's submission.
