#### **REGULATORY MATTERS**

Report No. 6.1 Somerset Street - Time Limit Changes

**File No:** 12021/1755

The purpose of this report is to gain LTC and Council support to amend the existing time limits along the Butler Street Reserve side of Somerset Street.

The image below shows:

- A yellow line showing the section of Somerset Street under consideration.
- Light Blue squares showing the location off existing time limit signage.
- A photo of the typical signage at each Light Blue square.



As seen by the photo above, parking along this section of Somerset Street is currently all-day parking between 6am to 1am, No Pay Parking and No Parking between 1am-6am.

Previously this section of Somerset Street had metered parking (as shown in google street view taken from 2017) but the metered parking was removed from this area and signage


was changed as part of the construction of the Byron Bay Bypass and the use of Butler Street Reserve for a stockpile and construction compound area.

The Byron Farmers Market will return to the Butler Street Reserve from Thursday 2<sup>nd</sup> December. Given the significant traffic generation and parking demand typically resulting from this market Council seeks to modify the time limit in this section of Somerset Street to aid parking turn over within the closest spaces.
