Amendment of timber plantation - AV0752P

Dear Stephen & Kimberly,

The amendments to your timber plantation **AV0752P** have been authorised under the *Plantations and Reafforestation Act 1999.* Please find enclosed an updated plantation plan, and a copy of your plantation certificate.

All establishment, management and harvesting operations must be carried out in accordance with the *Plantations and Reafforestation (Code) Regulation 2001* unless stated otherwise in the conditions of Authorisation. A copy of the Code is enclosed.

As a plantation manager/owner, you may have certain obligations under the *Rural Fires Act* 1997 to prevent bushfires. I therefore advise you to contact your local District Fire Control Officer to ensure you meet these requirements.

The assessment process included a search for places and objects of Aboriginal Cultural Heritage. There were no sites identified on your property at this time. The Due Diligence Code of Practice for the plantations industry allows a period of <u>12 months</u> for completion of any soil disturbance activities.

After this period, prior to any plantation operations which will cause soil disturbance, you will be required to undertake another search of the Aboriginal Heritage Information Management System to determine if any new sites have been registered within your plantation area. 
